About the role

Position's key responsibilities	• Provide high quality customer service to Library patrons; • Operate relevant software systems; • Maintain order of the library collection, shelving and organising books, processing new stock, identifying damaged items, and assisting with stocktakes. • Take payments • Process memberships • Receive and balance financial transactions as required and in accordance with Council procedures; • Engage with visitors to the library and provide customer service and support to a variety of library services relating to library loans, computers, information services, Wi-Fi, printing, scanning, and self-service technologies or other matters that assist patrons; • Deliver and support library programs, events and school holiday activities, as well as helping to promote services and encourage community participation; • Opening and Closing the Library; • Maintaining a clean, safe and welcoming environment, along with monitoring the library space and reporting any maintenance or safety concerns; • Other responsibilities as shall be reasonably associated with or incidental to the above responsibilities or as shall, in the course of the employment, be agreed between the parties as being or forming part of the duties.
Organisational responsibilities	• Ensure compliance with Workplace Health and Safety requirements. Comply with workplace procedures for risk identification, risk assessment and risk control. Participate in activities associated with the management of workplace health and safety.
