DM Gazey - Page 18 under Expectorate Services, I note there are many dogs at large reports. Also, that 18 dogs have been returned to their owners. Alderman Tapp Coutts - Page 19, do we install the safety house signs? MCRES - Safety House organisation comes under the NT Police.

Mayor Miller: Are Safety Houses identified by Neighbourhood Watch? MCERS – Yes.

Alderman Clark - Page 15 - Rubbish statistics are increasing. Is it because of the increase in alcohol containers?

MCERS – Yes, that is a contributor.

Alderman Zelley - Weed spraying at the Hot Springs, did we miss some Gamba grass?

MCERS – The grass in question is not Gamba Grass.

CEO - We are looking at irrigation and landscaping options for the Hot Springs as part of the ongoing revitalisation project.

Alderman Clark – Regarding the 5 year proposal for existing Waste Management Facility (WMF), How are we going to manage the process and keep it open to the public?

CEO - That's currently what are planning for. If we manage to increase the existing waste facility, that will also give us some options to raise some extra revenue.

DM Gazey - Page 24 Capital Funding, Plant & Machinery - we have budgeted \$743K to date and only spent \$180K. Will that cost increase when we get our Traxcavator? Do we know the expected time of arrival for the Traxcavator?

COO - The expectation is that the Traxcavator will leave Brisbane by the 24th May, there's no promises but that's the latest update.

Alderman Clark - Page 29, remote Civil charged for repairs to Gillard Crescent and then on page 32 they have charged us again for Gillard Crescent, have we been charged twice for the one job or were there two separate jobs?

XMCCD: The first charge was for roadworks in February. The subsequent charge was for more works in March for pothole repairs.

CEO – Council is yet to receive that funding.

# 13.8 KATHERINE LOW-SECURITY PRISON ADVOCACY

Alderman Tapp Coutts: Provided a media release from Minister Dale Wakefield about the Royal Commission Implementation Plan which announces \$71.4 M in funding to replace the Don Dale Detention Centre and other youth detention centres. \$8.9M has been allocated over 4 years, to empower local decisions. Maybe Katherine could tap into this to put together a proposal for a prison farm in Katherine. The government also announced that NT Prisons are running at 108% capacity.

Minister McCarthy advised at the LGANT Meeting in Darwin that the then Labor Government had commenced moving on a 200-bed facility at Katherine Rural Campus and had dropped Mataranka proposal prior to the last election. When Labor lost the election this was not pursued further by the CLP Government. Minister McCarthy indicated that he is very supportive of prison farms. A good example is Tennant Creek where people from the work camp help out with local events such as the Show, the Festival and sports carnivals and some have been trained as umpires for sporting activities. Others are getting jobs back in t the community and the work camps in Alice Springs and Tennant Creek achieving some really good outcomes. Alderman Tapp Coutts suggested that this motion/proposal be taken to the Big Rivers Economic Development Committee (BRREDC) to get this proposal in motion DM Gazey - I fully support the investigation into a prison farm facility. We are situated in a good position and stand to gain good benefits for the community. Mayor Miller – The timing is sometimes not right due to multiple factors, but I feel, in this instance, the time is right and the proposal is good for the town. Alderman Tapp Coutts - The timing is right for Katherine. Hopefully we will see a real change to our community in a decade, as a result.

### That it be recommended to Council to:

- 1. Direct the CEO to:
  - a) Further develop the proposal sufficient to address initially identified opportunities and constraints.
  - b) Seek further community input on the proposal.
- 2. Using the results of part 1 of the recommendation above, write a submission to and meet with the Hon Natasha Fyles MLA (Attorney-General and Minister for Justice) and the Commissioner of NT Correctional Services (Mark Payne) seeking their support and comment on the proposal.
