#### **OFFICER RECOMMENDATION**

1. That it be recommended to Council:

(a) That the acquittal for the 2021-2022 Local Government Grant – Provision of Local Government services to Binjari Community be received and noted, and the acquittal be forwarded to the Department of the Chief Minister and Cabinet, NT Government.

#### **PURPOSE OF REPORT**

To formally acquit the 2021-2022 Local Government Grant for the provision of services to the Binjari Community for the amount of \$139,100 (2021/2022 Grant) + \$18,894 (Carry over funds) totalling \$157,994 (GST exclusive).

#### **BACKGROUND/COMMENTS**

For a number of years Katherine Town Council has received funding from Department of the Chief Minister and Cabinet, NT Government for the provision of Local Government services to the Binjari community. For the 2021-2022 Financial Year the funding was \$139,100 + \$18,894 (Carry over funds) totalling \$157,994 (GST exclusive).
