PURPOSE OF THE REPORT

To seek authorisation from the elected members for Council to **not** opt out of the Shine Lawyers Katherine Contamination Class Action (PFAS).

REPORT

Council has received confidential legal advice with respect to Katherine Town Council's potential participation in the Class Action and the potential risks if Katherine Town Council chooses to opt out, with consideration of the good relationship with Defence because of Defence's work in addressing issues to date.

If Katherine Town Council does not remain in the Class Action, Katherine Town Council will have no legal entitlement to require Defence to fix any issues that may arise and will be relying on its relationship with Defence to ensure issues are remedied.

Defence has demonstrated a strong commitment to rectifying the effects of PFAS in Katherine, through being responsive and providing financed solutions to remedy issues.

Katherine Town Council will not be individually responsible for legal costs associated with bring the Class Action and will not have to provide any upfront legal fees. Katherine Town council will not be required to be actively involved in the progression of the proceeding, saving time and resources.

Katherine Town Council is committed and confident in the continuance of its strong working relationship with Defence.

OFFICER RECOMMENDATION

That it be recommended to Council that:

- Katherine Town Council does remain in the Class Action to provide for the interests and well-being of individuals and groups within the council area.
- 2. Council engage with Defence to communicate Katherine Town Council's decision to remain in the Class Action is to support the interests and well-being of individuals and groups in Katherine. Acknowledge the good work Defence has undertaken to date to remedy the impact of PFAS in Katherine and emphasise Katherine Town Council's commitment to support and work with Defence in its endeavours to address the impact of PFAS in Katherine.
