Purpose of Report

To seek endorsement from Elected Members to award Tender 19/05 Katherine Hot Springs Remedial Repairs & Landscaping to Stages 1 & 2

Background

Katherine Hot Springs has been a hot topic for the community and after considerable work, Council was pleased to close the current tender process on 31 May 2019.

Works are still currently scheduled to commence on Stage 1 (the bank section) in July 2019, followed closely by Stage 2 (the upper level) starting around October 2019, with the project planned for conclusion around the end of 2019.

Katherine Town Council understands that this has been an extended process and reiterate that over the past months we have undertaken numerous studies and engaged consultants to deliver the following:

- Geo-Technical Global Slope Stability Studies
- Civil & Structural Compilation Studies
- Architectural & Landscaping Compilation Studies
- Documentation of works
- Gaining all necessary approvals

Council believes it has adopted and incorporated a responsible approach to the long awaiting panacea. Despite construction works occurring, Katherine Town Council are happy to confirm that swimming will not be affected during this time, however, alternate routes will need to be taken. Katherine Town Council requests the community's cooperation and understanding during this time and request that all alternative access signage is adhered

ADVERTISING & SUBMISSIONS

Tender 19/05 Katherine Hot Springs Remedial Repairs — was advertised in the Katherine Times on 8 May 2019, as T19-05 Katherine Hot Springs Remedial Repairs & Landscaping Stages 1 & 2 and on an external provider, Tenderlink on the 2 May 2019, with the original submissions closing at 2:00pm on Friday 24 May 2019.

A number of prospective tenders requested an additional seven (7) day extension to the tender period. KTC in consultation with the assessment panel, granted this request. The amended closing date was 2:00pm Friday 31 May 2019.

Two (2) tender submissions were received in total and on time for the advertised tender T19-05, through the Tenderlink portal.

BUDGET IMPACT

KTC budget for the contract was estimated at \$2,006,380.00 (GST exclusive) based on a report provided by a quantity surveyors estimate.

Referenced in the following Schedule of Rates Summary table, are the two (2) tenders and their respective submitted values (GST exclusive);

SAVINGS by TENDERER
