4.1 Action Items Table:

2020/11 update - KTC A/DI&E went through initial contractor report, KTC has

spent \$10k on remediation works since the installation of the new

lights.

and installed by contractors.

6. OTHER BUSINESS

6.1 Oval 2:

KTC A/DI&E advised that the turf has been laid, reinstallation of goal posts and initial line marking to take place in the first week of June. At this stage the oval should be available to users by 7 June.

KRL representative asked for confirmation that the main field is 400m, can KTC supply specifications?

ACTION 2021/02: KTC to email oval specifications/design to KRL.

6.2 New Pavilion:

KTC A/DI&E advised that there has been a delay due to the wet season, possible completion date is now November/December. KTC will have a more definite timeframe when the slab is laid.

KTC DCS advised that the renaming of the building will go for public consultation in the middle of the year.

6.3 Katherine Rugby League Club:

KRL representative advised that the number of light tokens required for Oval 1 training is incorrect (need more than what is stipulated).

ACTION 2021/03: KTC to investigate as token configurations have not changed.

Maintenance Issues:

- Oval 1 very dry and patchy
- Toilets no soap/paper towels, is it possible to have a sanitary bin in the lady's toilet?
- Gates Adventure Play Park gate not getting locked
- · Bins not being emptied
- Scoreboard Remote currently sharing one remote with other users, does Council have any more?

ACTION 2021/04: DCS to check who has signed out other remote controls.

KRL representative requested approval to apply for a grant for a scoreboard for Oval 2 - attendees supported the request. KRL to email KTC outline of submission.

KRL representative advised that they did not go ahead with the Oval 2 storage shed grant submission as they did not get the quotes in time. Possibly combine with scoreboard application.

ACTION 2021/05: KRL to email A/DI&E outline of grant submission/s and have a meeting with KTC to discuss.

6.4 Big Rivers BMX:

Big Rivers representative asked if Council could keep up the water at the complex, getting dry and dusty. Also mentioned that there was no water at the watering points in between the tracks, needed for watering of the track.

BMX applying for a major grant to replace the current clubhouse, it will have a usable space with kitchen/canteen.

KTC representative requested a separate meeting to be had with KTC and BMX to discuss their submission.

BMX representative advised that plans had already been drawn up with KTC approval. DCS to locate documents.

ACTION 2021/06: DCS to locate previously submitted documents.

6.5 Katherine Tennis Club:

Tennis Club will be having their annual Open Day on the May Day long weekend; KTC representative advised that the shade shelters will be relocated before the event and the area around the toilet blocks will be tidied up before then as well.

It was also mentioned that the Tennis Club have been successful in obtaining a Coach/Manager for six months.

6.6 Katherine Athletics Club:

Athletics representative advised that the running track is patchy, dry and hard.

They also requested that the portable grandstands not be put on the long jump run ups; some of these may be a safety concern i.e., seat lifting, not affixed (nearly tipped over).

ACTION 2021/07: KTC to remove and have safety assessments undertaken.

6.4 Other:

- Alderman Hurley advised that one of the Softball pedestrian gate padlocks does not work.
- BMX representative advised they are having an event on Sunday 13 June and will be using the PA system.
- Tennis representative requested signage for tennis; KTC representative advised that Council is currently looking into updating signage for the entire complex.
