REPORT TITLE: ADDENDUM TO THE MOU FOR THE OPERATIONAL MANAGEMENT OF THE KATHERINE AQUATIC CENTRE

PURPOSE OF THE REPORT

To inform council of an Addendum to the memorandum of understanding (MoU) for the operational management of the Katherine Aquatic Centre (KAC) between the Katherine Town Council (KTC) and YMCA, defining the KAC boundary.

BACKGROUND

At the May 2015 Meeting of Council, the awarding of Tender 15/01 Management of the Katherine Aquatic Centre” to YMCA Katherine Inc was ratified by decisions of Council.

The purpose of the MoU is to clearly define the relationship between the Katherine Town Council and the YMCA. The MoU outlined areas of responsibilities for maintenance as well as defined financial obligations between the two parties for the operational management of the KAC. Omitted from the original MoU were the boundaries for the KAC, which are now presented as an addendum to council consideration.
