From a legislative point of view, Council has no jurisdiction in managing crime, police or the justice system.

Council, however, does have the ability to participate and advocate for action from the Territory and Federal governments. We can hold our Territory government to account on the promises made and the failure to have delivered those. Well intended policy has led to a high rate of incarceration at a great cost to taxpayers (estimated to be \$3852.00 per day per person or \$1.4M per year by the Justice Reform report 2021), understandably circumvented by defence lawyers in the interest of their clients and leading to community being held to ransom by a small number of repeat offenders.

Policy created in a vacuum almost always never works. Partnerships and collaborations are the only way forward to address these issues affecting us. There are many early intervention, evidence-based programs and strategies which I will be pursuing vigorously. I will work with community members and victims of crime to create crime prevention plans which can be implemented in partnership between community and the 3 tiers of government. I will work with councillors, the CEO, NGO's the Chamber and businesses to start these conversations and engage in actions and strategies that assist in the creation of a safer Katherine.

Different and varied approaches must be investigated because clearly, whatever we are doing currently is not working.
