#### 1. KATHERINE TOWN COUNCIL

Katherine Town is located at the heart of the 340,000km<sup>2</sup> Big Rivers Region. The Big Rivers Region consists of many rivers, with our town on the banks of the Katherine River.

We are the fourth largest town in the Northern Territory and a thriving regional centre for service delivery. The local government area of Katherine has a population of around 10,000 with 25.5% of residents identifying as Aboriginal and/or Torres Strait Islander. The council area includes four communities and homelands: Rockhole, Miali Brumby (Kalano), Binjari, and Geyulkgan (Walpiri camp).

We are also a hub for the surrounding region, so our strategic priorities have been developed on the basis that the town and our Council provides services to over 25,000 people.

Katherine is often called the crossroads of the north as we're found on the junction of the Stuart and Victoria Highways, connecting Australia from north to south and east to west, making us a vital through point for travellers, industry and local communities.

# 2. DESCRIPTION OF WORKS

Katherine Town Council (KTC) is seeking a schedule of rates from suitably experienced contractors for the management and control of declared weeds as outlined in the NT Weed Management Handbook and the Katherine Region Weeds Strategy in council owned road reserves as listed in below scope.

## 3. SCOPE OF WORKS

### 3.1 Description of Works

- Contractor will conduct weed spraying operations during the months of November through to May each year of the set term.
- Targeted weeds and weed management areas are outlined in below in sections 3.2 and 3.4. However, if additional weeds are identified in other management areas, contractor should treat and report to council officers.
- Weed spraying operations and treatments are to be carried out in accordance with the NT Gov Weed Management Handbook, available from the Weeds Branch.
- Days of works shall be Monday to Friday, excluding public holidays.
- Hours of spraying will be between 6am to noon, with up to a total of 600 hours per set term.
- The successful contractor will supply an indicative schedule for works, detailing proposed dates and areas for spraying operations to the council officer prior to the commencement of works. These will be used for relevant notifications to the public during the term of the contract.
- Spray logs of any application operations will be supplied to Council on a weekly basis.
- Daily spray data is to be recorded on the NTG's WeedMate App to assist with data collection and tracking of weed outbreaks. For help or information with the app please contact Katherine Weed Management Branch on 08 8973 8862.
- All weed management areas and council facilities are to be treated a minimum of twice during
  each term, all areas are to be monitored for return growth and seedlings. Should renewed
  growth occur, a third application will be required, as directed by council officer.



- Where available at council sites, contractor will be permitted to use suitable water supply.
   When unavailable, contractor will be required to incur costs of water and submit charges to council officer via invoice.
- Contractor will be responsible for the cost of herbicides and wetting agents required to conduct works. These costs need to be considered in the quotation price.
- Contractor will be responsible for the transport, spray, storage and disposal of all chemicals.
- All equipment must be supplied by the Contractor, at a minimum 200L Spray Tank with 80meter hose reel, 4wd or ATV Vehicle equipped with spray unit and capacity to cart water for emergency purposes, for basal barking 7L spray packs with diesel resistant seals are required.
- All vehicles and plant used in the process of this contract are to be registered with MVR and fitted with appropriate safety equipment.
- The Contractor is responsible for the safety and wellbeing of public members, as such safety signage is to be in place and supplied by contractor during any spraying operations.
- When spraying the Contractor must keep a copy of Safety Data Sheets in vehicle or ATV for chemicals in use.
- Contractor is responsible for personal safety of employees and it is a requirement that relevant PPE is worn.
- The contractor is responsible for reporting any items noticed (of any nature) requiring maintenance to Council via the Snap Send Solve App.
- Contractor is responsible for ensuring that all staff are suitably qualified and licensed in chemical handling and weed spray application.
- Contractor must hold current Professional Ground Spraying Business Licence
- At a minimum Traffic Management Plan is to be provided to council for approval and Advanced Signage are to be used for any weed spraying operations, i.e. Weed Spraying Operations Ahead.



# 4. PERIOD OF WORKS

Council is seeking to award the contract for an initial proposed contract length of 6 months, from the award date, for the 2025/2026 wet season. There is an option to extend for a further two 6-month wet season periods, at rates based upon Darwin CPI increases, if agreed between both parties, to a maximum of 18 months.

The contractor shall advise the Council eight (8) weeks before the agreement expires if he desires the agreement period to be extended.

Any further requests for works will be on an as needs basis and in line with Council's procurement policy.

# 5. CONDITIONS

- **5.1** Proposals must be submitted before the Closing Date and Time.
- 5.2 All prices must be in Australian currency and excluding GST.
- 5.3 The Request for Quotation (RFQ) is not an offer of contract by Council.
- 5.4 The lowest or any quotation will not necessarily be accepted.
- 5.5 Quotations must remain valid for a period of not less than 90 calendar days from Closing Date.
- 5.6 Public Liability Insurance Certificate of at least \$10 million dollars is required by council.
