IMPORTANT INFORMATION

Council determines the requirements for dog licence's as follows:

- NT Planning Scheme Zoned Rural, Agricultural and Water Management: No licence required on the number of dogs.
- NT Planning Scheme Zoned Rural Living, all other Zones including RAAF Base Tindal, requires a licence for more than 2 dogs - maximum 4 dogs.

Licences will only be granted following a thorough assessment and inspections that includes:

- the size of the property
- whether the fence is adequate to contain the animals
- an overall assessment of the premises as a suitable environment for the number of animals proposed to be kept at the premises.
- consultation with adjoining neighbours and surrounding properties.
- complaint history including consideration of any previous breach by or substantiated complaint against the owner under the Katherine Town Council By-Laws.
